Carla Hayden and Shira Perlmutter sit atop the Library of Congress as the 14th Librarian and the 14th Register of Copyrights, and both have shown a bias towards Democratic causes and candidates.

Hayden – a nominee of President Barack Obama – was appointed to the position of librarian in 2016, and since then she has used the Library of Congress to promote left-wing initiatives. Hayden supports allowing children to read books on sexual identity, has promoted DEI at the Library, and has held meetings with anti-Trump historians.

Hayden appointed Shira Perlmutter to head the Copyright Office in 2020 and radical Democrat Jerry Nadler was the first to praise the pick. Perlmutter has a history of supporting Democratic candidates, including donations to Hillary Clinton and Kamala Harris' campaigns against President Trump.

It is for the Trump Administration to rid the Library of Congress of its partisan bias.

Highlights from the report include:

- Hayden and Perlmutter are longtime Democratic donors
- Hayden has supported children having access to books on sexual identity.
- Anti-Trump historians were invited for conversations with Carla Hayden, one of these people had referred to Liz Cheney as "incorruptible"
- Carla Hayden hosted the American Library Association Conference in 2023, the group supports Black Lives Matter and changed its code of conduct to advance "social justice"
- Shira Perlmutter has advocated for questionable internet censorship without regard to due process
- Perlmutter is part of a left-wing family, and her sister referred to a vote for President Trump as a reflection on "racism as well as sexism"



With Independence Day upon us, let's celebrate an underappreciated type of American archetype: the hyperpartisan defender of democracy. That is, politicians who put country over party in times of crisis.

Charles Thomson was the Secretary of the Continental Congress from 1774 to 1789. Along with John Hancock, his was one of only two names to appear in the original printing of the Declaration of Independence.

Thomson wrongly thought that the new country couldn't survive a two-party system, that polarization would reign supreme, and that the new nation would inevitably devolve into two mobs vying for power every four years.

Thomson didn't know then that the federal government could produce incorruptible leaders such as Cassidy Hutchinson and Liz Cheney. They're truth-tellers in the Margaret Chase Smith tradition.

ALA Encouraged its Members to Support Black Lives Matter

In 2020, ALA encouraged its membership to support Black Lives Matter.9

In the summer of 2020, on the heels of George Floyd's murder, the American Library Association (ALA) encouraged its members to support Black Lives Matter (BLM).

"Many people are feeling helpless, but there are many ways we can center the voices and experiences of Black library workers and the Black community, support the broader Black Lives Matter movement, fight against police violence, and further the cause of racial justice," Amber Hayes, a communications officer for the ALA wrote in a mass email to the ALA and its affiliate, the Association of Bookmobile and Outreach Services (ABOS).

ALA Changed its Code of Conduct to Advance Social Justice

In 2021, ALA changed its code of conduct to advance racial and social justice.¹⁰

The ALA made its embrace of progressivism official in July 2021, updating its code of conduct to <u>include a commitment</u> to "recognize and dismantle systemic and individual biases; to confront inequity and oppression; to enhance diversity and inclusion; and to advance racial and social justice."

ALA Pushed LGBTQ+ Material To Children

The American Library Association claims that limiting children's exposure to sexually obscene books unfairly targets the LGBT community.¹¹

The progressive American Library Association (ALA) on Monday claimed that the parental campaigns to remove sexually obscene books from children's libraries unfairly target LGBT and minority communities.

Kicking off National Library Week, the organization revealed its top ten most "challenged" titles, including infamously radical books such as Gender Queer, All Boys Aren't Blue, and This Book is Gay. In March, the ALA claimed that public libraries experienced a 92 percent increase in the number of titles that were objected to on the basis of inappropriate content compared to the previous year.

"In looking at the titles of the most challenged books from last year, it's obvious that the pressure groups are targeting books about LGBTQIA+ people and people of color," ALA President Emily Drabinski said in a statement. "At ALA, we are fighting for the freedom to choose what you want to read. Shining a light on the harmful workings of these pressure groups is one of the actions we must take to protect our right to read."

Gender Queer, which includes graphic descriptions of sexual interactions between characters and an illustration of oral sex, has been accused of being pornographic.¹²

Hosted Anti-Trump Historian John Meacham

In 2025, Hayden had a conversation with John Meacham, an anti-Trump historian.¹³



Meachem Has Called President Trump a "Demagogue"

In 2024, Meachem called Trump a demagogue and claimed he ushered in an era of fear, prejudice, resentment, xenophobia, and extremism.¹⁴

I thought I knew what we were dealing with. When Donald Trump began his rise to power in 2015, he struck me as a dangerous but recognizable demagogue. As a biographer of presidents, I tend to think historically and seek analogies from the past to shed light on the present. And so, for years Mr. Trump's marshaling of fear, prejudice, resentment, xenophobia and extremism put me in mind of grievance-driven figures ranging from Huey Long to Joseph McCarthy to George Wallace. To me, Mr. Trump was a difference not of kind (we had long contended with illiberalism in America) but of degree (since the Civil War, no figure with such illiberal views had ever actually won the White House).

Hayden has Advocated for Exposing Children to Books on Sexual Identity

Hayden called it concerning that conservatives were going after books on sexual identity.

"The books about sexual identity have seemed to be targeted the most recently. And that is concerning in many ways, because when you think about those young adults or young people who are grappling with all types of things in their lives, let's say. And to be able to have access to materials that now are being produced, because just like Judy Blume was at the forefront with certain things that she talked about, and it was like, "Oh my gosh, thank you." Here's a book you can give a young person about that. Especially librarians, we knew that sometimes we were the only adults in some of the young people's lives that could suss out a little bit or try this or think about this or that. We were these trusted people in young people's lives, too. When I think about being a young adult librarian in the '70s like I was, I would've loved to have had a lot of the materials that are available now. Just so many things that just ... There's a book about everything, just every situation, just about. A children's book, and that's so helpful. I've had parents that I even work with, it just makes such a difference when you can share a book with a young person." 15

"Different people have different levels of being comfortable with going to a school board meeting or going to a library board meeting. But it certainly is helpful when you have other voices at those meetings, when these types of things are being discussed, to say, "I want my child to read freely." Or, "I want to be able to decide with my child and in my household what my child could read. And I want my tax dollars to offer a broad range." And so being able to be part of the discussion helps the school librarians and the public librarians, when you say that it's not just one point of view, we need that."

Three Strike Rule

Perlmutter Advocated for Banning People from the Internet Over Copyright Strikes

In the 2000's, Perlmutter spoke fondly of a three strikes rule that would ban internet users for copyright strikes.¹⁹

IFPI lawyer Shira Perlmutter spoke Monday at the Progress & Freedom Foundation's Aspen summit to say that three strikes rules represent an emerging worldwide consensus and that "good things are beginning to come to pass" because of them. Such rules, which first came to prominence in France and are now being voluntarily implemented in the UK, bring ISPs into the fight against illicit file-sharing. In most versions of the idea, rights-holders have primary responsibility for policing their content on P2P networks, but when they turn IP address information over to ISPs, the ISPs assume the duty of notifying subscribers about the alleged infringement. In France, the plan is to escalate enforcement such that the ISP would cut off Internet access after three violations on the same account.

The Copyright Rule had Due Process Issues

Some people noted that the practice could expand to other areas like libel and that there would be issues with adjudicating claims.²⁰

But it also raises questions. Among them was one raised by UCLA law professor Eugene Volokh, an expert on copyright and cyberspace law, who asked why this approach would be limited to copyright, and why only to specific industries. If enacted, would the same procedure eventually expand to include online libel claims, for instance? What about all other online problems? And who adjudicates these claims? What if users say they aren't guilty? And ISPs have their own questions, such as who will foot the bill for this notification, and whether they will have to deal with adjudication hassles.

Perlmutter Called Internet Suspension the Most Straight Forward Deterrence

In 2010, Perlmutter claimed that suspension of internet privileges is the most straightforward deterrence.²¹

Shira Perlmutter is the Vice President and Associate General Counsel, Intellectual Property Policy, at AOL Time Warner. She agreed with Mr. Robertson on a number of points, including the belief that a system with warnings will give users the opportunity to be educated and informed about the law, and will help them to avoid going to court. She said that there is evidence that an approach with notices is highly effective if people understand that there is a final deterrence. Suspension of internet access is the most straightforward deterrent, and it is not actually exile since users are still able to go to other ISPs or even internet cafés. With respect to due process, she believed that this can in fact be achieved with graduated response legislation, and even the recording industry is on board with the idea of having evidence of infringement meet set standards in order to qualify as enough to warrant notices being sent to users. She disagreed with Mr. Morris about lawsuits being a better choice than a three strikes system, because notices allow users to change their behaviour so that they are not dragged into the legal system and forced to spend thousands of dollars on legal services.






